

## Liberated Syndication Terms and Conditions of Use

### Web Site Terms and Conditions of Use

Review the terms and conditions for use of Liberated Syndication's ("Libsyn") services and product offerings. These Terms and Conditions of Service ("Terms of Service") apply to offerings ("Service") delivered via the Libsyn websites located at HYPERLINK "http://" HYPERLINK "http://www.libsyn.com" [www.libsyn.com](http://www.libsyn.com), and HYPERLINK "http://www.libsynpro.com" [www.libsynpro.com](http://www.libsynpro.com) and all associated sites linked to these by Libsyn, its subsidiaries and affiliates, including Libsyn sites around the world (collectively, "Site"). The Site is the property of Webmayhem, Inc. doing business as Liberated Syndication and as Libsyn and its licensors. Webmayhem, Inc. is a wholly owned subsidiary of FAB Universal Corp.

**These Terms of Service are a legally binding Agreement between you and Libsyn, governing the use of the Service. By use of the Site, you agree to abide by and are therefore bound by the Terms, together with all updates, additional terms, distribution licenses and all of Libsyn's rules and policies that collectively constitute the Agreement. If you do not agree to these Terms or do not have full power and authority to enter into this Agreement, do not use the Site or Service**

### Web Site Terms and Conditions of Use

#### I. AGREEMENT TO THE TERMS AND CONDITIONS

Again, BY USING THE SITE, YOU AGREE TO THESE TERMS OF SERVICE; IF YOU DO NOT AGREE, DO NOT USE THE SITE.

If you are seeking to upload content to the site or utilize other services within the site, you may be required to sign up for an account. As part of the account sign up, you will be asked to agree to these Terms of Service. By doing so, you will be deemed to be bound by these Terms of Service.

Visitors to the site may view or listen to content that does not require an account. However, through any use of the site you are agreeing to the Terms of Service.

Libsyn reserves the right, at its sole discretion, to change, modify, add or remove portions of these Terms of Service, at any time. It is your responsibility to check

## II. SITE CONTENT

Except as expressly provided in these Terms of Service, no part of the Site and no Libsyn Content may be copied, reproduced, republished, uploaded, posted, publicly displayed, encoded, translated, transmitted or distributed in any way (including “mirroring”) to any other computer, server, Web site or other medium for publication or distribution or for any commercial enterprise, without Libsyn’s express prior written consent.

You may use information on Libsyn products and services (such as data sheets, knowledge base articles, and similar materials) purposely made available by Libsyn for downloading from the Site, provided that you (1) not remove any proprietary notice language in all copies of such documents, (2) use such information only for your personal, non-commercial informational purpose and do not copy or post such information on any networked computer or broadcast it in any media, (3) make no modifications to any such information, and (4) not make any additional representations or warranties relating to such documents.

You shall be solely responsible for Your Content and all obligations and consequences of uploading or publishing Your Content. You agree and warrant that you own and/or have the rights to Your Content and all related Brand materials and Marks.

Libsyn does not warrant or endorse and does not assume and will not have any

liability or responsibility for Your Content. You agree that you will not use any third-party materials in a manner that would infringe or violate the rights of any other party and that Libsyn is not in any way responsible for any such use by you. Through use of the Site and Service, you are indemnifying Libsyn against all claims and liability related to Your Content.

### III. LIBSYN'S SERVICE

As used herein, the term "Service" means any service provided by Libsyn via the Site, including, but not limited to, the provision by Libsyn to you of specified connectivity, storage space and bandwidth for the hosting of your Podcast, enhanced features for Your Content, tools for distribution, iPhone apps and monetization services such as Advertising. Furthermore, whenever these Terms of Service refer to your use of the Site, said use shall be meant to include, but not be limited to, your use of any Service offered by Libsyn via the Site.

### IV. LICENSE TO LIBSYN

Unless otherwise agreed to, you hereby grant to Libsyn a non-exclusive, royalty-free, worldwide right and license for so long as you use the Site to do the following to the extent necessary in the performance of Services under this Agreement: digitize, convert, install, upload, select, order, arrange, compile, combine, synchronize, use, reproduce, store, process, retrieve, transmit, distribute, publish, publicly display, publicly perform and hyperlink Your Content; and make archival or back-up copies of Your Content. Except for the rights expressly granted above, Libsyn is not acquiring any right, title or interest in or to Your Content, all of which shall remain solely with you.

Libsyn may suspend or lock access to your account until payment for all outstanding balance is received and additional late fees may be incurred. Libsyn reserves the right to terminate your account and delete Your Content from the Site at its sole discretion if your account is “delinquent”.

Libsyn’s obligations, if any, with regard to its products and Service are governed solely by the agreements pursuant to which they are provided, and nothing on

In the event of any controversy or dispute between Libsyn and you arising out of or in connection with your use of the Site of any of its Content, the parties shall attempt, promptly and in good faith, to resolve any such dispute. If we are unable to resolve any such dispute within a reasonable time (not to exceed thirty (30) days), then either party may submit such controversy or dispute to mediation. If the dispute cannot be resolved through mediation, then the parties shall be free to pursue any right or remedy available to them under applicable law.

## XX. VOID WHERE PROHIBITED

## XX1. MISCELLANEOUS

If any of the provisions of these Terms of Service are held by a court or other tribunal of competent jurisdiction to be void or unenforceable, such provisions shall be limited or eliminated to the minimum extent necessary and replaced with a valid provision that best embodies the intent of these Terms of Service, so that these Terms of Service shall remain in full force and effect. These Terms of Service constitute the entire agreement between you and Libsyn with regard to your use of the Site, and any and all other written or oral agreements or understandings previously existing between you and Libsyn with respect to such use are hereby superseded and cancelled. Libsyn will not accept any counter-offers to these Terms of Service, and all such offers are hereby categorically rejected. Libsyn's failure to insist on or enforce strict performance of these Terms of Service shall not be construed as a waiver by Libsyn of any provision or any right it has to enforce these Terms of Service, nor shall any course of conduct between Libsyn and you or any other party be deemed to modify any provision of these Terms of Service. These Terms of Service shall not be interpreted or

construed to confer any rights or remedies on any third parties.

The Site may provide access to Libsyn international data and, therefore, may contain references or cross references to Libsyn products, programs and Service that are not announced in your country. Such references do not imply that Libsyn intends to announce such products, programs or Service in your country.
